BUDGET NO.1

- 2.000 to 12.000 Euro transferred to your organisations bankaccount
- 60% at the beginning, 40% after “ok” for Reporting
- No Co-Financing needed
- Max 15% “Support Costs”, Max 15% “Indirect Costs” (next slide)
- Exchange Rates: Monthly on InforEuro (we provide link, also part of contract)
- Template is simple, please make it understandable
- In a Partnership: Transfer to the “main” partner

BUDGET NO.2

Support Costs

such as **equipment** and **trainings** for staff members involved in the project cannot exceed **15%** of the total grant

Indirect Costs

administrative and **operational** fees, **rent**, **accounting** and **legal expenses**, etc., shall not exceed **15%** of the total grant.
