BACKGROUND

Fair Trade is a trading partnership, based on dialogue, transparency and respect, that seeks greater equity in international trade. It contributes to sustainable development by offering better trading conditions to, and securing the rights of, marginalized producers and workers – especially in the South. Fair Trade Organizations, backed by consumers, are engaged actively in supporting producers, awareness raising and in campaigning for changes in the rules and practice of conventional international trade. (*Definition of Fair Trade, Charter of Fair Trade Principles*)

The Fair Trade Advocacy Office catalyses collaboration within the international Fair Trade movement on policy, advocacy and campaigning activity; facilitates knowledge co-creation; and leads advocacy work on European Union legislation, policies and their implementation.

Our vision is the one of a world in which justice and sustainable development are at the heart of trade structures and practices so that everyone, through their work, can maintain a decent and dignified livelihood and develop their full human potential.

ABOUT THIS POSITION

You want to help create positive social and environmental impact in global supply chains as well as on the livelihoods of smallholders, artisan, and workers worldwide? You are interested in the trade-development-environmental protection nexus and its interconnectivity with EU policies and legislations? You have proven experience in advocacy? Then you might be the person we are searching for!

We are looking for a highly-motivated, experienced new team member to fil the current vacant position of Policy and Project Officer. We are looking for someone who is excited to learn and brings

in ideas for moving the debate for fair and sustainable development forward; and of course we are looking for someone nice to work with!

The FTAO is a small team, and aims to have impact in EU policies through cooperation in larger networks. We are therefore looking for someone who excels at coordinating a rich network of collaborators that include members of the Fair Trade Movement, other civil society organizations, trade unions, academics and private sector actors among others. As a member of a small team, you will be working on different issues simultaneously and carry out a wide diversity of tasks. You will be working in close contact with the rest of FTAO's staff members working in EU policies, and under the coordination of our Managing Director.

KEY AREAS OF WORK

- Implementation of the EU Regulation on deforestation-free products. This includes developing capacity building tools to increase readiness of cooperatives and local actors, facilitating engagement of producer networks and national Fair Trade platforms with relevant stakeholders (e.g., EU Delegations), developing expertise on needed accompanying measures and sectorial guidance, as we as the involvement in and dissemination of relevant in-house studies to EU policymakers.
- Review of the Directive on Unfair Trading Practices (UTPs) in business-to-business
 relationships in the agri-food supply chain. You will manage an externally funded project to
 advocate for more ambitious legislation in the field of UTPs. This will include overseeing
 external researchers developing studies on the impact of UTPs in non-EU farmers, engaging
 with the EC, and networking with allies.
- **Sustainable agri-food supply chains:** Work to highlight the interconnectedness of the socioeconomic and environmental pillars of sustainable agri-food supply chains through the lens of your own files, with a strong focus on the cocoa sector.
- EU elections: Coordinate and lead the Fair Trade movement's engagement during the 2024 EU elections. This will include supporting members of the movement in their engagement with candidates, and direct engagement with candidates and political parties; and after the election, lead on the evaluation of the results, and on the development of an engagement strategy with new MEP and EC. The Engagement activity will take place under the umbrella of the concept of a Global Green Deal https://fairtrade-advocacy.org/the-ftao-calls-for-transforming-the-european-green-deal-into-a-global-green-deal/
- Influencing the European Parliament's position for the next COP and other files related to EU policies relevant to **climate change** adaptation and mitigation

GENERAL RESPONSIBILITIES

- Draft position papers, articles and press releases, in coordination with colleague responsible for communications, write internal reports and analysis.
- Participate in research project, and commission and oversee research carried out by consultants, interns and volunteers.

- Engage with policy makers alone or within coalitions
- Represent the FTAO in various fora e.g., internal coordination working groups, CSOs coalitions, multi-stakeholder spaces.

Project management

- Manage and report on grants, in accordance with donor requirements, supported by our financial officer
- Identify external funding opportunities and put together funding proposals
- Support FTAO fundraising work
